### THE NEWSPAPER STRIKE

Brother Castle was invited to speak at a picket line meeting of the Newspaper Guild November 27th. He was asked because he had been on the P.1. picket line in the 1936 strike. That was the first newspaper strike in Seattle and it was for recognition of the Newspaper Guild, the newspaper workers' union. They won against opposition from many anti-union sources.

He spoke on the enormous size of that original picket line, one that extended clear around the block at Sixth and Pine Streets, three and four abreast. The meeting cheered the talk.

In addition, the members of the Editorial Board of the RUSTY HOOK were asked to join the Newspaper Guild. Castle accepted on behalf of the other editors, Art Mink and Fred Berg. They will sign up as soon as the applications come in the mail.

So, not only is the RUSTY HOOK printed in a union shop, it will now be edited by Newspaper Guild Union members.

### LONG LIVE THE ANTI-WTOers

The first anniversary of the anti-WTO Battle of Seattle is taking place as we go to press. It is another illustrious anniversary of the many anniversaries celebrated in our City. In 1919 we had the first general strike in U.S. history In 1934 we joined the waterfront workers of the entire Pacific Coast and made history by striking forcing the first wage gain in the Great Depression.

Also in the Thirties we elected a State Legislature that passed the first "Old Age Pension" in the U.S. The thirties also saw the birth of the Washington Commonwealth Federation, a left-wing independent political coalition that prompted an official of the Roosevelt administration to call the United States composed of 47 states and the "Soviet of Washington." It was pre-



cedent to the Green party of today.

Before that, during the first World War, Seattle Wobblies forced the Wilson administration to raise loggers wages and clean up the logging camps.

Seattle has a proud record of leading in bettering the lives of workers and people. Therefore, we welcome those organizing a celebration of the first anniversary of the Battle of Seattle. May there cause continue to spread around the world. Upon their efforts may rest the hopes of the people of the world.

Sept. 10, 2000

The meeting was called to order at 9:30 AM, Sunday, Sept. 10, 2000 at the Local 10 Pensioners' Meeting Room in the Local 10 Longshore Hall.

All were in attendance at roll call excepting: Bob Harvey, who was represented by his alternate; Lou Loveridge, vice president, was absent because of the serious illness of his wife, Dorothy. For the second time Robert Bolato of San Diego was absent without explanation.

There was one minute of silence in memory of deceased brothers and sisters.

Outgoing International President, Brian McWilliams, spoke to us for about ten minutes thanking us for past support.

Local 13, Wilmington, CA presented a resolution to raise the expense stipend for PCPA Executive Board Members attending the Board's two meetings per year to \$175.00 for one day only from \$100.00 previously paid. substantial pension benefits as they take part in the employer touted 401K plans.


This ended the 33rd Convention and we adjourned to meet in Seattle, Sept. 2001 for the 34th Annual PCPA Convention.



# Week of action an "outstanding success"

Figures released by the ITF today back up the organisation's claim that its recent Asia Pacific week of action (16 to 20 October) against sub-standard shipping was an outstanding success.

The figures are not yet fully complete, but according to the latest information:

•ITF inspectors, assisted by volunteers from seafarers' and dockers' trade unions, inspected 499 ships during the week.

•US\$1,258,816 of outstanding wages has been recovered so far. (Inspectors in Japan expect to achieve a further US\$334,696).

•23 new agreements were signed and more are under negotiation.

Stephen Cotton, Secretary of the ITF's Special Seafarers Department, stated: "Nearly 500 ships inspected, over one and a quarter million dollars recovered for crews so far – this has been a hell of an event. Everyone involved can congratulate themselves on putting in such a tremendous effort to make the seas safer for seafarers."

He continued: "We know that some owners have been keeping the worst of their vessels out of the ports in which inspections have been held. This week of action and the ones in Europe and North America have been immensely valuable in teaching us how to combat that kind of evasion. What we have learned in these events will allow us to plan even better targeted and more focused actions in the future."

The countries participating in the Asia-Pacific week of action were: Australia; Bangladesh; Canada (west coast); Fiji; Hong Kong, India; Indonesia; Japan; Kiribati, Korea: Malaysia; New Zealand; Pakistan; Papua New Guinea; Philippines, Russia (Vladivostock); Singapore; Solomon Islands; Sri Lanka; Taiwan; Thailand; Tuvalu, USA (west coast); and Vanuatu.

The week of action was designed to identify problem and unsafe shipping, fight for the rights of crews and highlight the abuses that the Flag of Convenience system too often allows to take place.
