**PCPA Executive Board Meeting
36th Annual PCPA Convention
Sept. 14, 2003**

The meeting was called to order at 9:00 AM at the Columbia River Double Tree Hotel in Portland, Oregon.

In attendance were: Joe Lucas, President; Lou Loveridge, 1st Vice President; John Johnson, 2nd Vice President; Arne Auvinen, Secretary-Treasurer and his assistant, Bonnie Eckert-McHenry; Delegates: Al Perisho, LA/Long Beach; Cleophas Williams, San Francisco; Ken Swicker, Longview; Barbara Lewis, Alternate, Columbia River; Joe Jakovac, Southern Oregon; Phil Lelli, Tacoma; and Paul McCabe, Seattle. Canada was represented by Bill Duncan, Van-Isle Ports and Joe Schmillier, Vancouver. Lois Stranahan, Columbia River, was unable to attend because of illness. Harry Black and Frank Graham representing Australia's MUA National Veterans' Association were our honored guests.

Reports were made by the various delegates: Vancouver, Canada is having contract negotiation problems and there has been a 98% strike vote; Cleophas Williams spoke on the Harry Bridges Memorial planned in San Francisco; Seattle has created a second dock for Alaska Cruise Ships and it appears that the port will lose more and more space to non cargo docks in the future.

George Romero, International Welfare Officer, spoke calling attention to the post-contract internal conflict in the PMA with the resulting probability that we can't rely on them to keep their word.


We need to be fully prepared for the next negotiation

particularly on the health care issue and how it will be affected by whatever National Health Care Congress might put together by then.

PCPA Constitutional changes were the main business of the Convention. The proposal was to split the Secretary/Treasurer office and eliminate the office of 2nd Vice President maintaining a slate of four titled officers: President, Vice President, Secretary and Treasurer. This proposal was directed to the main body for vote. Also directed to the main body were nine resolutions regarding such things as National Prescription Drugs, Support of the Alliance of Retired Americans, raising the amount of retirees' life insurance from \$5,000 to \$10,000, overturning NAFTA, Monitoring Long Term Care and Assisted Living and opposing Patriot I & II.

The meeting was adjourned.

Oil Energy Axis

We wrote elsewhere about the overwhelming power of Oil-Energy in U.S. government. Now we see it in all its glory in the energy bill being debated in the US Senate.

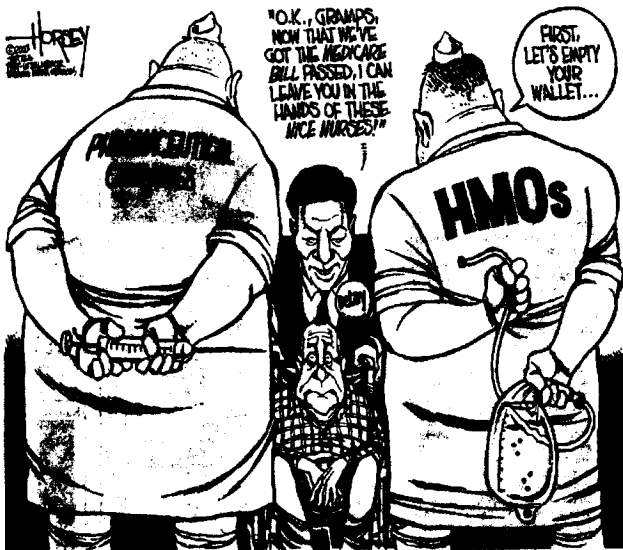
Senator Cantwell, D-WA., among others, "says the bill is riddled with flaws, providing vast benefits to the coal, natural gas, oil and nuclear industries while offering few environmental protections." Quoted in the Seattle Post Intelligencer, 11/21/03.

Further on the article states:

"The bill also includes \$23.6m in tax breaks, with about two-thirds going to the oil, gas and coal industries ... It also contains \$18 billion in loan guarantees, to build a pipeline to bring natural gas from Alaska's North Slope. "

It may seem funny, but we always thought private industry under capitalism was supposed to invest its own money in enlarging its business. But it seems the idea of a socialist program for industry, outright grants from taxes paid by ordinary citizens, is the new idea.

This provides funds for all business expense while industry gets all the profits and Bush tax cuts to boot. On the other hand, socialism for industry is being accompanied by a program of privatizing social services, that is, not tax supported, which started the other way around.



War of Mass Deception

So much has been written about war in Iraq and the war against terrorism that you may be getting tired of it. At the risk of further adding to the general tempest, we would like to draw attention to what we consider a major weakness in Bush's war effort.

Bush and his crowd of war mongers have grossly misjudged the political savvy of the American people. In spite of all the propaganda advantages at his disposal, Bush has only gotten bare majority support according to the polls. And even that majority is diluted by a percentage who just go along because it is the patriotic thing to do, regardless of the facts.

Lying to gain support for war has always been part of the game. But there has to be some measure of credibility mixed in. But all of Bush's lies have hardly seen the light of day before they exposed as unadulterated lies. It seems as if they didn't care whether anyone believes them or not.

If that is their attitude toward us, the same attitude adopted toward the United Nations and the rest of the world, then we are in for a power struggle to rule the world - not one to spread the blessings of democracy. The "blessings of democracy" is just another part of war propaganda. So the war effort (or conquer the world effort) is divided within itself. Besides sharply divided support, there is a new split developing. The rule the world strategy raises serious opposition in the corporate world itself. European corporations are rightly concerned about U.S. control of the world economy.

Thus we see France and Germany refusing to join the war as well as other nations around the world, including Japan. The great American super power is being seen more and more as an imperialist power out to build a world empire at the expense of whatever rival corporate power that gets in the way.

Even more opposition to Bush imperialism is a developing corporate opposition at home. Lesser U.S. corporations have begun to wonder if the Oil-Energy corporate combine would move in on some of them that might be rivals or just gobble them up through super corporate profit raids. The Bush war policy is now being seen as not only U.S. corporate world domination, but also Oil-Energy U.S. corporate control.

This picture is reminiscent of the war against Hitler. Hitler's world power grab threatened European and U.S. corporate power. They were able to unite against Hitler, and with the help of the Soviet Union and the peoples' anti-fascist forces, remove the threat. So then it could be said that a truly widespread, powerful movement against Bush, Oil-Energy imperialist schemes is in place and increasing. It is an informal peoples coalition extending all the way from radical peace groups to corporate segments.

If you count all the other peoples forces opposed to Bush including unions, environmentalists, churches, feminists, civil rights groups, socialists, senior citizens, unemployed, poverty population, and third world liberation movements and all others suffering at the schemes of the power hungry Bush imperialists, you see there are real reasons for optimism in the struggle to limit and eventually do away with all corporate domination of the world.

You can help bring that about by using the weapon of your vote. To vote Bush out of office is critical to the future of unionism, democracy, peace and prosperity. Due your duty!

More Class Warfare

You may have read the editorial in the latest Dispatcher by James Spinosa, ILWU International President regarding the new European assault on longshore unions. If not, we wish to bring it to your serious attention.

His opening paragraph sounds a warning: "The decades-long war by ship owners on dock workers and their unions keeps erupting on different fronts around the world. And as the conflict rages on, we see more and more clearly the ties between governments and multi-national corporations."

What Spinosa is referring to is a proposed new law being considered by the European congress that would assign all cargo handling at dockside to ships' crews. The law also proposes that dockside workers needed to supplement would be hired as casuals - in the name of "free market competition."

Spinosa further states:

"Knowing these lessons {of last years negotiations} we can see where the European port Directive points. If the employers get away with gutting European dockers' contracts, it wont be long before union longshore contracts in the U.S. and elsewhere will be declared "monopolistic" and international pressure will build to get rid of these "uncompetitive" practices. We will soon find ourselves in the line of fire again."

GOOD NEWS! - After the above article in the last Dispatcher, the vote on the EU anti-longshore proposed law called the "European Directive on Port Services," was voted down in the EU congress by a vote of 229 against and 209 for.

"This is the most historic victory for dock workers ever in Europe and maybe the world," said Nick Stam, coordinator for the Dutch dockers' union FNV Bondgenoten and a member of the ITF's Dockers' Steering Committee. "Never has one group of workers in the history of Europe been victorious against the bureaucracy of politicians and Capital. To my brothers and sisters in the ILWU say 'An injury to one is an injury to all.'"

ILWU President Spinosa warned that the victory is not final and that ship owners and other corporate powers will continue to try to bust docker unions in other ways. "We must stay vigilant and extend our international solidarity," Spinosa said.

The above longshore victory counts as number two with our victory in our new contract. Number three will be the defeat of Bush in 2004.

Shipping News

According to Seattle Times reporter, Stephen H. Dunphy:

"Container volumes at the Port of Seattle for April were up 19 percent compared with April 2002, driven mostly by Asian traffic. The shift in value of the dollar may change the equation later this year, but for now imports rule.

So far this year, the total is up by 16 percent more containers to 441,186 versus the first four months of 2002. Part of the increase is due to a new lease with Northland Services, which operate barges between Seattle and Alaska. Part of it is due to a general increase in inbound goods from Asia to be refilled with goods bound for the U.S., according to the Port."

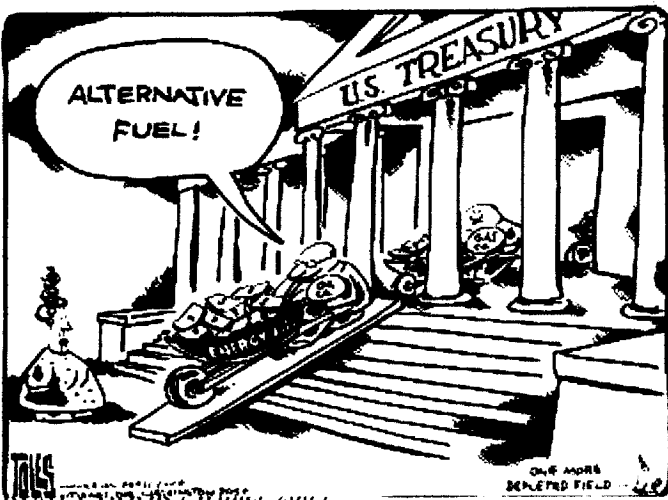

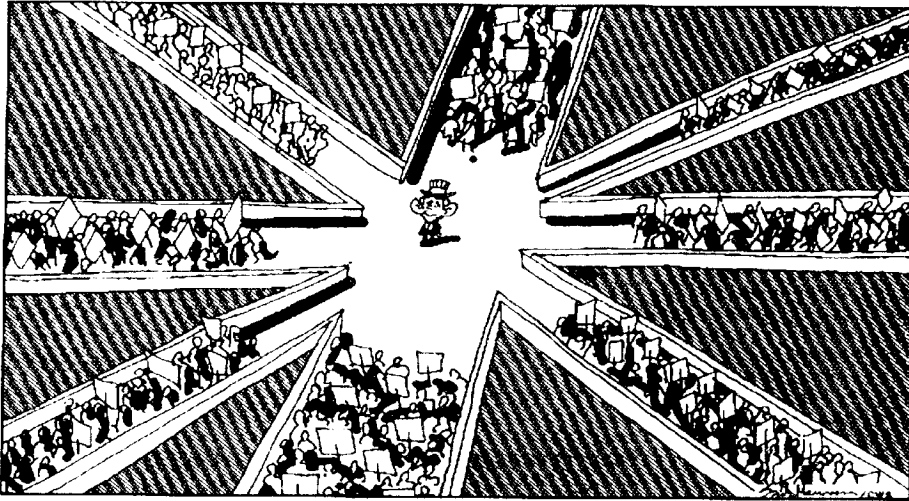
