# COMIC TEAM IN KYIV GETS INTO HOT WATER

A member of Parliament in Zelensky's party, Roman Hryshchuk, protests against what he calls the slanderous stereotype that only comedians run the government of Ukraine. But reporter Andrew Kramer observes that Zelensky has surrounded himself with people "drawn from his comedy studio" and the entertainment industry (movie producers and directors). Mr. Hryshchuk, who is incidentally another comedian, points out that there are also noncomedians in the government. And Zelensky

himself says that he is now showing his serious side and has not told a joke in public for two years. However, a former Zelensky supporter, Dmytro Razumkov, who was ousted as Speaker of Parliament last October, to be replaced by – you guessed it – a comedian, Ruslan Stefanchuk – is outraged. He says Zelensky's penchant for "show business figures" has created a government of "hapless ministers and aides." He adds: "We came for a comedy" and "wound up watching a horror movie" (New York Times, 12-26).

In an article reprinted in the Times on Feb 21st, Ukrainian reporter Olga Rodenko complains that the trouble with Zelensky is his "tendency to treat everything like a show." What he has to say is less important than the entertaining gestures that accompany it. Furthermore, he is "notoriously thin-skinned when it comes to criticisms and challenging questions," adds Rodenko, eventually coming to rely on "the loyal rather than the qualified."

When Zelensky came to power in 2019 it was clear that stable rule in Ukraine could not be achieved if some degree of autonomy were not granted to the Russian-speaking and Russia supporting areas of the Donbas adjacent to Russia. A letter from a Fulbright scholar who spent time in Ukraine in 2003 writes that the Ukrainian nationalists of the time realized that they could not be a strong united country unless the "considerable segment of the population that leaned toward Russia felt included" (NYT, 1-26). The outlines of a peaceful solution were laid out in the Minsk 2 agreement negotiated by France, Germany, Russia and Ukraine in 2015. In return for considerable autonomy, the rebellious areas agreed to disarm and return volunteer Russian soldiers back to their homes (Anatol Lieven, The Nation, 11-29-21). Informed observers realized that Ukraine could never achieve greater unity than that. In response to the efforts of reactionary nationalists to turn all of Ukraine into an "anti-Russia" the people of the Luhansk and Donetsk areas had conducted revolutions. It was too late to reabsorb them back into a Western-leaning Ukraine. Russia would never allow it. It would be like King George trying to reabsorb the United States after the American revolution.

Zelensky, however, seemed completely oblivious to this reality. From the beginning he said that his aim was to recover the "lost territory." Ukrainian prosecutors brought hundreds of cases against people in Donbas for treason and sedition. Ukrainian troop commanders wanted to "take our land back." An eyewitness with an interesting history, a Russian speaker but arrested and imprisoned in Donbas after switching to the Zelensky side, then freed in a prisoner exchange, declares: "The thing is, the Ukrainian Government doesn't know what it is up against. They have the optimistic belief

that they can end the war and free Donetsk and Luhansk. This isn't going to happen" (James Verini, "Ukraine's Forever War", NYT Magazine, 1-23-22). Zelensky seemed to have the hope that increased military aid would allow him to prevail without granting any autonomy to the East. But the more he accumulated advanced weaponry the greater threat he posed to Russia. Biden provided hundreds of millions of dollars in military aid but it never seemed enough. On February 20th Zelensky accused the West of "appeasement" (NYT 2-21). This was after Estonia, Lithuania and Latvia got U.S. permission to transfer Javelin anti-tank missiles and Stinger anti-aircraft missiles to Ukraine. And Turkey gave Ukraine a Turkish self-navigating drone which, used for the first time in October, destroyed a howitzer from miles away (NYT, 2-4). Astounded Russians, thinking they had been attacked from the air, scrambled planes in self-defense.

It seemed no big deal to Zelensky for Ukraine to become a member of NATO, though this would be the equivalent of Mexico or Canada becoming a member of a military alliance opposed to the United States. Yet the U.S. declared it was a "nonstarter" to even consider the idea that Ukraine could be banned from ever becoming a NATO member. It seemed as if every country in Europe could provide for its own security - that is, every country but Russia. As NATO members beefed up their arms and absorbed member countries closer and closer to Russia, Russia supposedly had nothing to worry about because NATO was a defensive alliance. But the true nature of a military alliance is not determined solely by the members of that alliance. The country at which the alliance is directed has a different perspective and its opinion needs to be factored in to get the full picture.

I took a quick shower, dressed and headed down stairs. Sue was already hard at work dealing with deliveries and such. She motioned me in and directed me to the warmer and my breakfast waiting for me. Afterword I had a day to kill, so I hailed a cab and headed for the city.

I arrived back at the bar late after taking in a movie, so I headed right for Harry's table. Sue saw me come in and brought over a couple of beers, sat down and asked, "Did you have a good day?" I smile, "Yes, "I got tired and thought

I'd take in a movie, it ran longer than I expected it would." Just as I was about to take a drink of my beer, Harry appears. "I read your sign and was about to leave, then decided, what the Hell. There is a highly sensitive military installation in Poland surrounded by razor wire. A man living in the area says: "I don't know anyone who has ever been inside." The U.S. maintains that the MK41 launchers inside are defensive in nature but some independent experts believe the launchers could easily be refigured to be employed offensively (NYT,2-17). Isn't it understandable that Russia should feel threatened by this?

What could easily be understood in the case of any other country cannot be fathomed because our unreasoned hatred of Russia goes so deep. As Ukrainian flags are being waved everywhere the situation in the Donbas never gets proper coverage. "My Family didn't ask to be Liberated" headlines an article from a woman with family members in Donetsk. But if you read the article in full you see her family is not representative. "My aunt and uncle have never approved of the self-proclaimed separatist republic." But she admits that most of the people around them felt quite different. As a result, "their circle has grown smaller, making them feel even more isolated and angry" (NYT, 2-27). They were the equivalent of Tories in a time of revolutionary ferment!

Russia had given ample warning. Troops had surrounded Ukraine and the Biden administration had tried to prevent an attack by calling for talks – talks that would not grant any of Russia's demands. Putin protested that he did not want to have "idle talk for decades" but on January 10 it was conceded that burying Russian demands in endless discussions was "exactly what Washington and its European allies would like to do" (NYT, 1-11). As Andrei Sushentsov, dean of the School of International Relations at Moscow University pointed out, Western Europe had been lulled into thinking that security could be obtained for free rather

than something that had to be negotiated. It was necessary to make clear to them that they were running a great risk by ignoring Russia's position (NYT, 2-9). Meantime commentator Bret Stephens argued that, since Putin is a dictator "whipping up periodic foreign crises" you couldn't make any concession to him whatsoever, not even a security demand which would be reasonable for any other country on earth. In Russia's case this would be "appeasement" and would only embolden him to make other demands (NYT,1-26).

The present situation is very dangerous. It is not possible to evaluate the full significance of the Russian incursion into Ukraine, as I write this on March 4, since it is still in its early stages. The U.S. may loudly declare that stories of persecution of Russians by Ukraine are nothing but "false tales" (NYT,2-20) and that Putin has no reason whatsoever for his invasion, but it has to be acknowledged that if Putin is "insane" then

#### **ILWU-PMA Benefit Plans Office Contact Information**

As of December 1, 2021, the Benefit Plans Office in San Francisco has returned to full, in-person operations, and we are ready to assist the membership from 9 AM to 5 PM, Monday through Friday. Our new telephone number is: 888-372-ILWU (888-372-4598)

The phone will no longer be answered by a live operator. We are now using an automated phone tree that will guide you to a customer service representative best able to assist with your call. To get to the Pension Department, press the number 1 and listen for your options. To get to the Welfare Department, press the number 2 and listen for your options. To speak with someone regarding medical claims, press the number 7 and you will be transferred to the Coastwise Claims Office.

## ILWU-PMA Welfare Plan – Coastwise Indemnity Plan COVID-19 Over-the-Counter at-home Test Kits for Medicare Retirees (March 14, 2022)

This notice applies to all ILWU-PMA Welfare Plan members and beneficiaries with Medicare Part B enrolled in the ILWU-PMA Coastwise Indemnity Plan. Effective January 15, 2022, COVID-19 over-the-counter at-home test kits are covered through the Coastwise Indemnity Plan with little or no cost to you. You were previously notified that coverage would be available through your pharmacy benefit administered by OptumRx. OptumRx will not be administering this benefit for members enrolled in Medicare Part B. Centers for Medicare & Medicaid Services announced that in early spring of 2022 Medicare will cover over-the-counter COVID-19 tests. In the meantime, the Coastwise Claims Office will reimburse the costs of up to 8 tests per individual per month – at \$12 per test, upon receipt of a claim with proof of payment. To obtain a claim form to submit your claim, go to www.benefitplans.org. You can also obtain the form by calling the Benefit Plans Office @ 888-372-4598, or Andrea Stevenson, WA Area Welfare Director, @ 206-938-6720.

Medicare beneficiaries can request four free at-home COVID-19 test at covidtests.gov delivered free by the U.S. Postal Service. You can also call them at 800-232-0233.

## **Announcement Regarding Pension Form 1099-R**

IRS Form 1099-R's were mailed out at the end of January to all Pensioners and Survivors. If you have not received yours, please call (415) 673-8500 or (888) 372-4598 or email the Pension Department at (pension@benefitplans.org) to request a duplicate.

Pensioners and Survivors may have received 1099-R forms where Box 12 thru Box 19 have been misnumbered. However, the box descriptions and the amount showing beneath each description is correct. For example, your 1099-R may incorrectly show "State Tax Withheld" as box 12 on the 1099-R form. The correct box number for "State Tax Withheld" is box 14. Please note that the dollar amount in the "State Tax Withheld" box is correct. Corrected forms are being mailed to the affected individuals. This updated form will have the "CORRECTED" box at the top marked with an "X".

For those who moved out of or into the State of California during 2021 you may have received two 1099-R's; you will now receive one 1099-R with all the information combined.

## Important notice regarding the ILWU-PMA Coastwise Indemnity Plan (CIP) Prescription Drug Program (February 2022)

For those who have medical coverage under the Coastwise Indemnity Plan. The following information pertains to your Optum RX drug plan.

The Trustees of the Welfare Plan reached deadlock on a motion of the Employer Trustees concerning non-essential drugs. On December 14, 2021, a decision was made by Coast Arbitrator John Kagel.

In short, claims for certain prescription drugs will require prior authorization by Innovative Care Management (ICM) if the drug claim cost is \$500 or more. If prior authorization is granted, it will apply to the prescription including refills, except where a new prescription is required for a refill.

This award will remain in effect unless modified by the parties in 2022 bargaining or thereafter reviewed and modified by the parties or the trustees or, in the event of their deadlock, the Coast Arbitrator.

## February 2022, a formal letter pertaining to this decision was mailed to participants from the ILWU-PMA Benefit Plans.

If you run into trouble trying to fill a prescription, Optum RX has a 24-hour member help desk @ 1-800-797-9791. This number can also be located on the back of your Optum RX prescription card.

#### From Medicare.GOV 1.20.22

Good news! Each household in the U.S. can now have four free COVID-19 at-home tests shipped directly to their home at no cost! All you need to do is visit COVIDtests.gov and enter your contact information and mailing address.

The tests are rapid antigen "at-home" or "self" tests — not PCR tests which require a lab drop-off. The "at-home" or "self" tests can be taken anywhere and give results within 30 minutes.

Guard against scammers trying to steal your personal information. When ordering tests, use the official, secure government website: https://COVIDtests.gov. Watch out for phone scammers, too. If you get a phone call requesting information so that free at-home tests can be mailed to you, hang up — it's a scam!

Remember: Medicare pays for COVID-19 tests performed by a lab, such as PCR or antigen/rapid tests, at no cost to you when the test is ordered by an authorized health care professional. Those in a Medicare Advantage Plan should check with their plan to see if their plan offers coverage and payment for at-home tests.

the 68% of Russians who declared in a poll that they supported his "special military operation" are also insane (See Alexy Novalney opinion article in NYT 3-3). In a sober analysis in the Times on March first, we read that "it was far from clear whether the sanctions would help turn more Russians against the war or whether they would only increase their resentment of the West, confirming that the United States and Europe were determined to dismantle their country." And in reply to a French declaration that Europe would wage "total economic and financial war" against Russia, former Russian Prime Minister Medvedev (Remember him?) declared: "Watch your tongue, gentlemen. Don't forget that in human history economic wars often turn into real ones" (NYT, 3-2).

If, as seems likely, increased sanctions do not deter Putin, what then? Anriy Yermak, the head of Zelensky's Presidential Office, says we need to kick Russia out of the United Nations and also institute a no-fly zone (NYT, 3-3). Great. Dogfights in the air between Russian and American planes. Maybe the initiation of World War Three. As tensions deepen, will more Americans agree with Yermak?

Winkin Blinkin and Company may gloat over the lopsided vote at the UN condemning Russia. But more meaningful, I would suggest, is the vote of abstention cast by China, questioning the resolution for not giving full consideration to the "history and complexity of the current crisis," an abstention supported also by India and 34 other nations, including half the countries in Africa. An additional 12 countries refused to vote at all.
