* Brothers: As a Supplement to our existing Union Life Insurance we have available to us a new life insurance program, "New Life II", which provides whole or ordinary life insurance which can be paid off in a minimum of five years, with no premium payments thereafter. This insurance is good to age 95. The premiums may be a little higher per year, but you have to remember that you are only paying for a short period of time. The insurance also offers cash values tied into the current interest rate.

ADDITIONALLY, GROUP SERVICES OF WASHINGTON AND ALASKA HAS PUT TOGETHER A LOSS OF INCOME/DISABILITY PROGRAM TO AUGMENT THE CURRENT DISABILITY PROGRAM PROVIDED THROUGH THE UNION.

VACATION INFORMATION

Vacation notices were given out with the payroll checks on Feb. 15th.

If you were off on illness and/or injury in 1984 and did not make your 800 hours for the 1st week or 1300 hours for the 2nd week, or if you are in disagreement with rate of pay, qualifying years, etc., you may file a claim for adjustment. To file for adjustment due to injury/illness, bring in your medical documentation to the Secretary's office immediately. To file a claim for adjustment of skill rate, etc., stop by the Secretary's office to fill out a claim. You must file your claim by March 18, 1985 to receive your full vacation pay in April.

Vacation checks will be issued April 12, 1985.

The final deadline for adjustments is May 31, 1985, and the final vacation adjustment checks for 1985 will be issued to our members on June 14, 1985.

WELFARE ELIGIBILITY

If you did not make your 800 hours in 1984 due to illness or injury, you must file an eligibility claim form with the ILWU-PMA Benefit Plan to receive health coverage, a qualifying year, etc. Please bring your medical documentation to the Secretary or Welfare office as soon as possible, so as not to interrupt your coverage.

Remember it is your responsibility to obtain the proper medical and compensation documentation so that we can effectively assist you in processing your claim.
